Joint Communication of Credit Suisse Fund Management S.A. and Aberdeen Global Services S.A.

Further to the agreement of Credit Suisse to sell parts of Global Investors to Aberdeen Asset Management PLC in return for an ownership stake in the enlarged Aberdeen group, notice is hereby given to the Unitholders of the Fund that the following changes will take effect as of **8 March 2010**:

1. The current Management Company, Credit Suisse Fund Management S.A., will be replaced by Aberdeen Global Services S.A.;
2. Aberdeen Global Services S.A. will also be appointed as registrar and transfer agent in replacement of Credit Suisse Asset Management Fund Service (Luxembourg) S.A.;
3. The current Custodian Bank of the Fund, Credit Suisse (Luxembourg) S.A., will be replaced by BNP Paribas Securities Services, Luxembourg Branch;
4. Credit Suisse Asset Management Fund Service (Luxembourg) S.A., in its capacity as administrator (other than registrar and transfer agent), will be replaced by BNP Paribas Securities Services, Luxembourg Branch;
5. Credit Suisse Group AG, in its capacity as promoter of the Fund, will be replaced by Aberdeen International Fund Managers Limited;
6. The Class R in CZK of Credit Suisse MultiFund (Lux) Constellation Global Aberdeen will be closed down on 25 February 2010 and related redemption proceeds per unit will be calculated on 1 March 2010, credited to the respective depositary/client with value 3 March 2010. The redemption proceeds which have not been claimed within six months after the close will be deposited with the "Caisse de Consignation" in Luxembourg until the end of the limitation period.

Communication of Aberdeen Global Services S.A. as future management company of the Fund

In addition to the above mentioned changes, notice is hereby given by Aberdeen Global Services S.A. to the Unitholders of the Fund that the following changes will take effect as of **8 March 2010**:

All instructions for buying and selling Units will be executed at the price next calculated after receipt of the instruction (so 13:00 Luxembourg time on each Dealing Day);
10. The appointment of the current Selling Agents will cease and Aberdeen International Fund Managers Limited will be appointed as Global Distributor;
11. The Fund will be renamed "Aberdeen MultiFund (Lux)";
12. There will be no changes to the respective "Investment Policies" and "Risk Profiles" as mentioned in the Prospectus of the Fund;

Unitholders of the Fund who do not agree to the changes set out above have the option of redeeming all or part of their units free of charge until 3 p.m. (Luxembourg time) on **3 March 2010**. To secure the implementation of the changes noted above, the Management Company decided that orders for issues, redemptions and conversions of Units of the Fund received after 3pm (Luxembourg time) on 3 March 2010 and on Thursday 4 and Friday 5 of March 2010 would not be accepted, and investors should next send orders for issues, redemptions and conversions of Units of the Fund to the new registrar and transfer agent Aberdeen Global Services S.A.. on 8 March 2010. (Provided they are received prior to the 13:00 cut-off time such orders will be executed with the Net Asset Value calculated on Monday 8 of March 2010).

Subscription, redemption, conversion applications for Units in the Fund shall be sent to the current registrar and transfer agent Credit Suisse Asset Management Fund Service (Luxembourg) S.A up until 3.00 p.m. CET on 3 March 2010. From 8 March 2010 and thereafter Unitholders must send new applications for subscription, redemption, conversion of Units in the Fund to the new registrar and transfer agent Aberdeen Global Services S.A..

Unitholders may obtain the new Prospectus, new Simplified Prospectus and copies of the new Management Regulations free of charge from the registered office of the future Management Company as from **1 February 2010**.
